RE: IHLS Pay Grades

Background

The IHLS Board of Directors approved our current pay grade assignment plan on April 27, 2021. The previous pay grade assignment schedule was adopted by the board in 2013. IHLS staff initiated the work on a new plan in FY2021, as the original did not allow for vertical growth including mandatory adjustments to minimum wage. The plan approved in 2021 allows for appropriate placement for new hires and staff new to a position. Our compensation plan is designed to ensure fairness and equity, complying with all applicable laws and regulations regarding protected classes. Decisions regarding compensation are made objectively and without bias.

A multi-part project allowed IHLS to get to the 2021 plan and maintain it for several years:

- Step 1: all position descriptions were redesigned to reflect actual responsibilities and organizational needs (FY2021)
- Step 2: pay grade assignments based on market analysis adopted, and staff brought to at the least the minimum grade (FY2021)
- Step 3: formula vetted by external consultants placed staff appropriately within their pay grade based on education, experience, and library system service (FY2022)
- Step 4: pay grade assignments maintained based on external research and IHLS budget (FY2023 – FY2024)
