RE: FY2023 Capital Projects Fund Budget Amendment & Edwardsville Roof Request

for Proposal

Background

IHLS Edwardsville building roof replacement is budgeted in the FY2023 Capital Projects fund for \$135,000. The Request for Proposal (RFP) for this project was posted in September, and we received eight total bids at the bid opening on Thursday, October 6. Based on the bids received and our recommended roofing contractor for this project, we will require an amendment to the FY2023 Capital Projects budget.

Recommendation for Roofing Contractor

IHLS staff recommends awarding CCR Roofing Service, LLC. for the Roof Replacement project as they were the lowest responsible bidder. Included below are the bid results. Please consider this recommendation to present to the Facilities Committee at their October meeting. The awarded bid will require final approval at the special October board meeting.


<u>Capital Project Fund – Budget changes for FY2023</u>

Capital Outlays – Building & Improvements (Expense | 5765):

The proposed increase of \$40,000 reflects the total estimated cost of the project. This includes the bid price, the optional pricing for additional items, and approximately \$10,000 for any additional work for the project that is unforeseen. A change order would be required should any price increases occur beyond the total bid amount.
